Admission Fee	Rs. 50,000/- (Rs. Fifty thousand only) One time payment at the time of admission, Non Refundable
Security Deposit	Rs. 10,000/- (Rs. Ten thousand only) One time payment at the time of admission, Refundable
Registration Charges	Rs. 3,500/- (Rs. Three thousand five hundred only) One time payment at the time of admission, Non Refundable
Session Fee Including Tuition fee, Annual Charges, Food charges, Field Trips, Enrichment Events and Celebrations.	Rs. 1,57,000/- (Rs. One lakh fifty seven thousand only) This does not include Transport charge which is optional.

Payment Schedule	
Payment to be made at the time of admission (First Instalment of Session Fee: Rs. 65,000/- + Admission Fee + Security Deposit + Registration Charges)	Rs. 1,28,500/- (Rs. One lakh twenty eight thousand five hundred only)
Second Instalment July 2025	Rs. 58,000/- (Rs. Fifty eight thousand only)
Third Instalment November 2025	Rs. 34,000/- (Rs. Thirty four thousand only)

Transport Charges	
Rs. 38,000/- (Rs. Thirty eight thousand only) for the whole session irrespective of distance. Subject to revision due to increase in fuel charges or imposition of any tax. Payable as follows:	
First Instalment (of Transport Charges) July 2025	Rs. 20,000/- (Rs. Twenty thousand only)
Second Instalment (of Transport Charges) Nov. 2025	Rs. 18,000/- (Rs. Eighteen thousand only)

Late Fee	Rs. 100/- + (Rs. 10/- per day)

- Transport facility is chargeable and optional.
- Transport facility is extended only from and to the residential address as mentioned in the application form. In case of address change, this facility will be provided only on existing routes, subject to availability of room in the vehicle plying on the route.
- We do not guarantee that every child will be picked up from and dropped off at the doorstep.
- GST, if levied on any of the fee/facility charges, will have to be paid by the parents.
- Generally fee/facility charges are revised upwards by approximately 5% to 10% every year as per need.
- In case of withdrawal after the admission formalities are completed, the admission fee will not be refunded in any case.
