Admission Fee	Rs. 50,000/- (Rs. Fifty thousand only) One time payment at the time of admission, Non Refundable
Security Deposit	Rs. 10,000/- (Rs. Ten thousand only) One time payment at the time of admission, Refundable
Registration Charges	Rs. 3,500/- (Rs. Thirty five hundred only) One time payment at the time of admission, Non Refundable

## **Transport Charges**

First Instalment (of Transport Charges)   July 2025	Rs. 20,000/- (Rs. Twenty thousand only)
Second Instalment (of Transport Charges)   Nov. 2025	Rs. 18,000/- (Rs. Eighteen thousand only)

Late Fee

Rs. 100/- + (Rs. 10/- Per day)
